### **Confidentiality & Nondisclosure Agreement**

This Agreement is made on the date indicated below, by and between Sacred Mysteries Distribution (“Company”) and the undersigned (“Recipient”) in order to prevent the unauthorized disclosure of Confidential Information, as defined below, regarding a film production by Company presently entitled, Quantum Qi (“Project”).

#### **1. The Purpose**

The Company and The Recipient wish to explore a potential business relationship in connection with which the Company may disclose its Confidential Information to the Recipient. (“Relationship”)

#### **2. Confidential Information**

Confidential Information means any information disclosed by the Company and/or those individuals or organizations working in collaboration with the Company, whether written, electronic or oral, that relates or refers directly or indirectly, to the Project. Information will be disclosed to the Recipient to determine whether Recipient is interested in hosting preview screenings of the Project distributed by Sacred Mysteries Distribution.

Company will provide a link to the preview screener for the Project for consideration of possible preview screening events hosted by Recipient. The Recipient agrees that the Recipient will protect the confidential material and information, which has been disclosed between the owner and the Recipient.

### **3. Protection of Confidential Information**

Recipient understands that private showings for family, friends, other organizations, etc. are not allowed as it violates this non-disclosure agreement and therefore, Recipient agrees to no private showings with the exception of necessary viewing for administrative decisions or partners involved in the event decisions.

### **4. Time Limit Upon receipt of this signed agreement**

Recipient will be provided with the url and password to preview the Project. Recipient will have one week from that time to view the Project, at which time the link will expire.

### **5. Copyright Infringement**

Nothing in this agreement is intended to grant any rights or licenses to the Recipient with regard to any and all of the Company's copyrights in the Project.

### **6. Usage**

This agreement does not provide the right to hold any screenings whatsoever. A separate screening permissions contract will be provided for that purpose.

### **7. Miscellaneous**

This agreement shall be binding upon and for the benefits of the parties, and their successors and assigns, provided that Confidential Information of the Company may not be assigned without the prior written consent of the Company. Failure to enforce any provision of this Agreement shall not constitute a waiver of any term hereof and if any provision of this Agreement is held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. This Agreement is the complete understanding of the parties and any amendment must be in a writing signed by the parties. This agreement shall be governed by and enforced in accordance with the laws of the State of Colorado. The Recipient agrees that any violation or threatened violation will cause irreparable injury, both financial and strategic, to the Company and in addition to any and all remedies that may be available, in law, equity, or otherwise, the Company shall be entitled to injunctive relief against the threatened breach of this Agreement by the Recipient without the necessity of proving actual damages.
